Avery/Mitchell to award sidewalk contract to Hunt Bros. for \$31,087.75. All ayes. Motion carried.

4. Blight Ordinance – Meeting will be held here Dec. 3, 6 pm. McGregor volunteered to be a Board representative on the Blight Committee.

NEW BUSINESS:

1. Snow Plowing – Received new prices for plowing from current contractor. Price increased \$5.00 per plowing from FY 2012-2013.

Booth/Mundt to contract with Mio Fence to do snowplowing for this year with increased prices, and re-bid next year. All ayes. Motion carried.

Booth/Mundt to pay Mio Fence the annual cost of \$650 for plowing the sidewalk by the school. All ayes. Motion carried.

- 2. Streetscape Bids Special joint meeting will be held with Mentor at 6 pm on Dec. 16, 2013 to open and award the bids.
- 3. Discussed closing Northwood Club for winter. No additional reservations have been received. Avery/McGregor to close Northwood for winter. All ayes. Motion carried.
- Consumers Update to Street Light Contract Changing street lights from mercury vapor to hi-pressure sodium. This year Consumers changed 3 street lights. Resolution 2013-10 would amend the current contract and authorize the Clerk to sign the new contract.

Booth/Mundt to adopt resolution 2013-10 to amend the current streetlight contract with Consumers, and authorize the Clerk to sign the contract.
