Balances: General Fund - \$199,813.93; Cemetery - \$15,328.45; Parks - \$8,030.02; Roads - \$138,842.74; Fire Millage - \$129,071.78; Luzerne Fire - \$144,300.05.

Fire Report

Attended fire 2/20 (-31 degrees). Truck froze up; is now at CSI for repairs and will be down at least another week.

Should have new truck from USFS for spring fire season (for Wildland fires).

Approx. \$20,000 left in grant after purchase of turn-out gear and SCBA. Can amend the grant to include a Boom Box and compressor to fill SCBA, total \$18,445.

Mitchell/Booth to authorize Dak to amend the grant to allow the purchase of a Boom Box and compressor to fill SCBA. All ayes. Motion carried.

Assessor's Report

Working on Board of Review, should be completed this week.

Committee Reports

Tri-Town – Interviews for Friday cancelled, looking at 4/9 (Thurs) to review applications for Chief and do interviews.

Steiner Museum – Requested money for a well and a lean-to. Lions Club will be building a 24x48' pole barn rather than building lean-to.

Utility Authority – More frozen pipes but not as bad as last year.

- 1. Steve Goldman, USFS, re: roads USFS considering a program that would donate 100% of timber receipts to road and trail repairs. In order to qualify for the program, roads or trails must involve a stream or wetland area. He would like a list of our priorities to present to the Cadillac District office.
- 2. Cemetery Fees Proposed to increase open/close fee to \$500, and not charge fee for marking a grave for a foundation. There will still be a fee for pouring foundation. Proposed additional income would be saved in the Cemetery Fund for site preparation on the north side of the existing cemetery.

Avery/Mitchell to raise cemetery open/close fee to \$500. All ayes. Motion carried.

3. Meeting dates for 2015/2016 – Trying to come up with a better time that fits work schedules better.

Mitchell/Mundt to change regular meeting to 3rd Thursday at 7 pm beginning April, 2015. All ayes. Motion carried.

4. Pay rates – Discussed raising pay for Luzerne firefighters to be equal to the pay for Tri-Town firefighters.

Booth/McGregor to raise fire run pay for Luzerne VFD to \$16.00/hr. All ayes. Motion carried.

Discussed pay rate for Deputy Treasurer, Deputy Clerk and maintenance personnel.

Booth/McGregor to raise hourly rate for deputies and maintenance personnel to \$11.50/hr. All ayes. Motion carried.
