FIRE REPORT

Firefighters responded to a structure fire, 1 vehicle accident, 1 property damage accident. Two Firefighters in FFI training ongoing now.

• New Firefighter Packet – Brian Hudson - was on Luzerne Fire Dept. previously, trained and certified. Has been on Tri-Town Fire Dept. and now would like to come back to Luzerne. Chief Shepard and Asst. Chief Wyrembelski requested he be approved.

Avery/Booth to return Brian Hudson to the Luzerne Fire Dept. as firefighter. All ayes. Motion carried.

Would not be probationary as he already has all the certifications.

Replaced toilet and pumped septic tank at Fire Dept. Really small tank and septic system. Will have to address it at some time with a larger system.

Ellis would like to see the Dept. obtain 2-3 sets of ice cleats, approximately \$30 at Luzerne Hardware.

Mitchell/Mundt to authorize Luzerne Fire Dept. to purchase 4 sets of ice cleats. All ayes. Motion carried.

Working on assessment roll; Consumers is preparing estimates to replace some of the center span streetlights with LED or high pressure sodium.
